

Ida Crown Jewish Academy Student User Agreement and Acceptable Use Policy:

Ida Crown Jewish Academy has purchased iPads for each new incoming student for the purpose of supporting our strong educational mission and commitment to 21st century teaching and learning. The school's goal in providing the iPad is to promote educational excellence by facilitating resource sharing, innovation, research, creativity, communication, increased productivity, and mobile learning. Students will be issued an iPad with predetermined applications (Apps) installed. They will have this iPad for the entire ICJA high school experience.

Use of these technologies is a privilege that carries responsibilities and behavioral expectations consistent with all school rules and policies. It is understood that members of the ICJA community will use all types of computing devices and the school's network in a responsible, halachic, ethical, and legal manner at all times. We expect our students to exercise good judgment and to utilize technology with integrity.

While students may use this iPad for personal needs, it is considered a required school supply that students must bring to campus each day to maximize learning. ICJA owns this device and retains the right to collect and/or inspect the iPad at any time and to alter, add, or delete installed software. Upon graduation, students have the option to either purchase their iPad for \$100.00 or, if it is still in good condition, return it to ICJA.

Receiving your iPad

Students and their parent/guardian must sign this iPad User Agreement & Acceptable Use Policy signature page. The student must then bring this form to Rabbi Segal during an iPad setup session where the student will submit this form, and then setup and receive an iPad.

Responsibility

Students are responsible for the general care of the iPad they have been issued by the school. Any iPad that has physical damage or fails to work properly must be taken to the ICJA Technology Office for an evaluation of the equipment. All repairs on the iPad must be done via the ICJA Technology Office and will be the responsibility of the student. Families who desire to purchase insurance coverage may either purchase AppleCare+ through the school, or may purchase third party insurance. More information about each of these options will be available closer to the start of school.

iPad Set-Up

ICJA will pre-configure the iPad with the necessary Apps for school. The software/Apps originally installed by ICJA must remain on the iPad and be easily accessible at all times. From time to time the school may add or modify software applications through the ICJA device management software. The iPad may be inspected at any time to ensure the iPad is configured per school policy. However, even though the iPad is school property, students are permitted to personalize their iPads as long as this does not interfere with the academic intent of these devices.

Acceptable Use

The use of the ICJA technology resources is a privilege, not a right. The privilege of using the technology resources provided by the school is non-transferable or extendible to people or groups outside the school.

Student Acknowledgements and Responsibilities for Ida Crown for iPad Use:

1. I will use my iPad in ways that are appropriate, educational, and that meet Ida Crown Jewish Academy expectations.
2. The iPad is the property of ICJA and I am granted the right of use only.
3. This right to use is subject to inspection by ICJA at any time for any reason, both physically and remotely.
4. The right to use does not contain any expectation of privacy for me and my use.
5. I understand that consistent with ICJA expectations, I will not use this device on Shabbat or Yom Tov.
6. I will report any mechanical or technical issues to the technology department.
7. I agree to use the iPad for appropriate, legitimate, and responsible communications only.
8. I will take no action that could interfere with ICJA network.
9. I will make every effort to ensure that the ICJA owned iPad is not damaged, lost, or stolen while in my possession.
10. In the case of damage, loss, theft or vandalism, I understand that I am responsible for repair or replacement fees.

I, _____, hereby agree to all 10 items stated above.

Furthermore, I _____ release Ida Crown Jewish Academy and its personnel from any and all claims and damages of any nature arising from my use of, or inability to use the school technology, including but not limited to, claims that may arise from the unauthorized use of the iPad to purchase products or services. I understand that it is impossible for ICJA to restrict access to all controversial materials, and I will not hold the school responsible for materials accessed via the internet on the school's network. I also agree to report any inappropriate iPad use to the Administrative team.

I accept full responsibility of this technology when not in the school setting, and understand that I am subject to the same rules and agreements when not in school.
